

# GREENGUARD® BUILDING WRAP LIMITED WARRANTY

## Residential 10 Year Limited Warranty

Pactiv Corporation warrants to the initial owner of a home using it's GreenGuard® brand building wrap, that RainDrop®, MAX®, Ultra Wrap and Classic Wrap building wraps will perform to Pactiv's published specifications for a period of ten (10) years from date of purchase, if installed in strict accordance with installation instructions provided by Pactiv and accepted industry standards in a properly designed and constructed wall system.

Pactiv will pay for the cost of labor and materials to correct problems found to be caused solely by failure of GreenGuard® RainDrop®, MAX®, Ultra Wrap and Classic Wrap building wraps that fails to perform according to the product specifications as per the limited warranty stated above.

This Limited Warranty does not apply to damage due to abuse or mishandling of the product, improper installation, or damage which is caused primarily by someone or something other than Pactiv's product. This Limited Warranty is the user's sole and exclusive remedy under tort, contract, or statutory law. The Limited Warranty is provided to all homeowners who have GreenGuard® RainDrop®, MAX®, Ultra Wrap and Classic Wrap building wraps installed on their homes on or after January 1, 2011, and who have registered with Pactiv as provided below.

For warranty registration to be valid, the initial homeowner must submit a GreenGuard® Warranty Registration Form with proof of purchase (which may be a letter or invoice from the builder or a building material supply company invoice) to Pactiv at the following address:

Any claims under this Limited Warranty must be made in writing to Pactiv Corporation at the above address within 90 days of discovery of the issue giving rise to the claim. To be valid, all claims must identify the residence address, the warranty claimant and the nature of the claim. If Pactiv determines that an investigation of the claim is necessary, the claimant must allow access to a Pactiv representative to view the property specified in the claim, including the taking of photographs and samples as required.

EXCEPT FOR THE ABOVE LIMITED WARRANTY, PACTIV MAKES NO OTHER WARRANTIES, EXPRESS OR IMPLIED, AND DISCLAIMS ALL OTHER SUCH WARRANTIES, INCLUDING BUT NOT LIMITED TO WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. IF SUCH IMPLIED WARRANTIES CANNOT BE WAIVED UNDER APPLICABLE LAW, THEY WILL ONLY BE APPLICABLE FOR ONE YEAR AFTER THE INITIAL PURCHASE OF THE PRODUCT. OTHER THAN ITS OBLIGATIONS UNDER THE LIMITED WARRANTY ABOVE STATED, IN NO EVENT SHALL PACTIV BE LIABLE TO ANY PERSON FOR ANY DIRECT, INDIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY KIND, INCLUDING BUT NOT LIMITED TO LOST PROFITS OR REVENUE, LOSS OF USE, PERSONAL INJURY OR DAMAGE TO PROPERTY CONTENTS.
